Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families.

Applicability. The Form HUD-50075-ST is to be completed annually by **STANDARD PHAs or TROUBLED PHAs**. PHAs that meet the definition of a High Performer PHA, Small PHA, HCV-Only PHA or Qualified PHA do not need to submit this form.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

Our Public Housing for seniors has 40 applicants on the waiting list. Rental values are moving upward and will continue to do so as many residents are no longer looking to buy homes. Based on the foregoing the HHA is committed to building and attaining more affordable housing units and Section 8 Vouchers. If using Project-Based Vouchers (PBVs), provide the projected number of project-based units and general locations, and describe how project basing would be consistent with the PHA Plan. <i>N/A</i></p> <p>The HHA intends to undergo the Streamlined Voluntary Conversion process.</p> <p>A Streamlined Voluntary Conversion Plan (“SVC Plan”) is being developed in collaboration with the residents of the Hollywood Housing Authority’s (HHA) public housing development of 90 units, Driftwood Terrace (“the Property”), the Property’s Resident Advisory Board, and the City of Hollywood, Florida, and is being developed following the regulations of 24 CFR Part 972 and other HUD guidance. By submitting the SVC Plan and its corresponding application (“the Application”) to the Special Applications Center (“SAC”), the HHA understands and commits to close out its Section 9 public housing program in its entirety. The conversion of the last public housing property of 30 units, Apollo Terrace, is anticipated to commence within 24 months of the financial closing for the Property. The HHA also agrees that it will not use its Faircloth authority to develop any new public housing units.</p> <p>In summary, the HHA will be submitting the SVC Plan and the Application to SAC to convert 90 of its remaining 120 units of public housing. A second SVC will occur for Apollo Terrace and is anticipated for 2026-2027.</p> <p>The SVC for Driftwood Terrace is attached to this plan and includes the relocation plan for any anticipated relocation of the residents. Driftwood Terrace will remain affordable housing for the elderly. Driftwood Terrace will be disposed to the HHA affiliated not-for profit (501(c)(3)) or another affiliated entity to undergo a substantial rehabilitation for long term financial and physical sustainability. This plan will not impact the availability of affordable housing in the community.</p> <p>HHA intends to exercise its option, as needed, to utilize project-based vouchers for the conversion of both Driftwood Terrace and Apollo Terrace. PBVs will be allocated to projects, as needed, within the HUD guidelines and rules for project basing housing choice vouchers.</p>

It is the policy of the Hollywood Housing Authority to comply fully with all rules and regulations governing Fair Housing and Equal Opportunity in housing and employment.

Hollywood Housing Authority shall not deny any family or individual the opportunity to apply for or receive assistance under the Section 8 Program on the basis of race, color, sex, religion, creed, national or ethnic origin, age, family or marital status, handicap or disability or sexual orientations.

The Hollywood Housing Authority will meet its commitment to full compliance with all applicable Civil Rights laws on Federal, State and local level to all Voucher holders. To ensure equal opportunity and affirmatively further fair housing the Hollywood Housing Authority has dedicated itself to the expansion of landlords on our programs, thereby giving voucher recipients greater flexibility where they live especially with areas that are not designated as low income. In addition, our Community Service Seminars, review legal rights under both Federal and State law on Housing issues. Our program was the first in Broward County to initiate a web site for landlords to list their properties, thereby allowing clients greater access to a larger available pool of housing opportunities. A separate list is also maintained by the HHA with properties that are available for the disabled with special needs. In partnership with Henderson Mental Health Center Inc., Hollywood Housing Authority with grant funding from HUD and Broward County opened the first SRO project (40 units) for the homeless in Broward County history. The City of Hollywood continues to institute a coordinated effort with Hollywood Housing Authority for targeted outreach to public housing and Section 8 tenants. Outreach includes but is not limited to housing workshops and one on one counseling. The city has targeted ADDI funds toward participants in the Housing Authority Self-Sufficiency Program.

The aforementioned Civil Rights Laws include but are not limited to the American Disabilities Act of 1990, the Age Discrimination Act of 1974 and Title IX of the Education Amendments Act of 1992.
